Applications are invited from eligible candidates for filling up a post of Dietician Group 'B' on temporary basis in VMMC and Safdarjang Hospital, New Delhi. The post is reserved for persons with Disability with OA(One Arm), OL(One Leg), BL(Both Leg), HH (Hearing Impaired) effected. The Number of vacancies, scale of pay, reservations, age and the requisite qualifications in respect of this post is indicated in Annexure-A.


1. The applications should be submitted directly to the **Medical Supdt., VMMC & Safdarjang Hospital, New Delhi** thereby mentioning clearly the name of the post applied the name of the Employment Exchange, Regn. No. and NCO No. etc.
2. Eligible and interested candidates should send their applications in the prescribed Performa (Annexure-B) alongwith attested copies of the testimonials so as reach the Safdarjang Hospital within 30 days from the date of advertisement published in Employment News. All the testimonials must be attested by a Gazetted Officer. (However if last date for submission of applications falls on national holiday, Sunday or any other holiday declared by Govt. of India, the next working day will be assumed as closing date).
3. Applications, which are incomplete in any manner, would be summarily rejected. Candidates must ensure that the application is complete in all respects. No correspondence what-so-ever shall be entertained in this regard.
4. In case the number of applications received is large, the experience/qualification can be raised by the Competent Authority or the written test may be conducted.
5. Circular is also available on the website of hospital.
6. Crucial date for determining the age limit shall be the closing date for receipt of application. Even if closing date will be extended due to national holiday or Sunday or any other holiday declared by Govt. of India, crucial date for determining the age limit calculated from the 30th day from the date of issue of advertisement.
7. Persons having 40% or more disability would be considered eligible for reservation under Physically handicapped quota as per rules.
8. Upprage limit for direct recruitment is relaxable for Physically Handicapped and Govt. Servants as per rule of Govt. of India.
