(4) Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.

(5) The bidder is also required to submit original instruments in respect of earnest money, original copy of affidavits, and credit facility certificate which shall be dropped into the Tender Box kept in MS office block, Safdarjung Hospital, New Delhi on or before bid opening date/time as mentioned in critical date sheet.

**(6) The hard copy of technical/financial/ price bid is not required to be submitted.**

(7) Bids will be opened as per date/time as mentioned in the **Tender Critical Date Sheet**. After online opening of Technical-Bids the results of their qualification as well Price-Bid opening will be intimated later.

(8) The Invitation for Bid documents is not transferable.

(9) In the event of Bid Opening date being declared as a holiday / closed day for the purchase organisation, the tenders will be opened on the next working day at the appointed time.
