- (1) Medical Superintendent Safdarjung hospital, New Delhi, on behalf of the President of India, invites **online bids** for the procurement of I.V.fluids from the Manufacturing firms having form-fill-seal technology or blow-fill-seal technology (as per Drug & cosmetic rules 1945 act as amended up to date) for VMMC & Safdarjung Hospital, Atal Bihari Vajpayee Institute of Medical Sciences (Previously Known as Dr. R,M,L,Hospital), New Delhi from the eligible firms. **Manual bids shall not be accepted.** Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.

2. Bids shall be submitted online only at CPPP website: <https://eprocure.gov.in/eprocure/app>.
3. Tenderer are advised to follow the instructions provided in the 'Tender documents for the e-submission of the bids online through the Central Public Procurement Portal for e Procurement at <https://eprocure.gov.in/eprocure/app>.
4. Tenderer who has downloaded the tender from the website www.vmmc-sjh.nic.in or Central Public Procurement Portal (CPPP) website <https://eprocure.gov.in/eprocure/app>, shall not tamper/modify the tender form including downloaded price bid template in any manner. In case if the same is found to be tempered/modified in any manner, tender will be completely rejected and EMD would be forfeited and tenderer is liable to be banned from doing business with all procuring agencies as stated at point 1 above.

5. Intending tenderers are advised to visit the website www.vmmc-sjh.nic.in and CPPP website <https://eprocure.gov.in/eprocure/app> again atleast 3 days prior to closing date of tender for any corrigendum / addendum/ amendment.
6. The **Hard Copy of all original Documents/instruments i.e. EMD and Affidavits** must be dropped into the Tender box kept in MS office block, Safdarjung Hospital, New Delhi **on or before bid opening date/time as mentioned in critical date sheet. However for all legal disputes/litigation/disputes only online uploaded copies will be acceptable.**
7. **Bid Validity** : The tender shall remain valid for acceptance for a period of 180 days (One hundred and Eighty days) after the date of tender opening prescribed in the TE document. Any tender valid for a shorter period shall be treated as unresponsive and rejected.
 - (i) In exceptional cases, the bidders may be requested by the purchaser to extend the validity of their tenders up to a specified period. Such request(s) and responses thereto shall be conveyed by mail or by post. The bidders, who agree to extend the tender validity, are to extend the same without any change or modification of their original tender and they are also to extend the validity period of the EMD accordingly. A bidder, however, may not agree to extend its tender validity without forfeiting its EMD.
 - (ii) In case the day upto which the tenders are to remain valid falls on/ subsequently declared a holiday or closed day for the purchaser, the tender validity shall automatically be extended up to the next working day.
8. **Modification and Withdrawal of Bids**: A bidder may modify or withdraw his online bid after submission as per the facility provided in the CPP Portal, only prior to the date and time prescribed for end of submission of Bid. No bid shall be modified after the date and time for end of submission of bids. No bid may be withdrawn in the interval between the deadline for submission of bids and expiry of the period of bid validity specified. Withdrawal of a bid during this period will result in bidders forfeiture of Earnest Deposit (EMD).
