Invitation of E/online tender (Non- transferable) for providing food items for main kitchen at VMMC and Safdarjung Hospital (SJH) New Delhi.

On behalf of the Hon' ble President of India, Medical Superintendent Safdarjung Hospital, New Delhi invites **online tenders at the lowest possible rates under the two bid system (Technical and Price Bid) from registered agencies having sound financial credentials for awarding the annual rate of contract for purchase of kitchen consumables items as per list Annexure (I) for the period of one year. Manual Bids shall not be accepted.**

3. Bids shall be submitted online only at CPPP Website: <https://eprocure.gov.in/eprocure/app>. in two covers - Technical & Financial
4. Tenderer/ Bidder are advised to follow the instructions provided in the tender documents to the contractors/ tenderer for the e-submission of the bids online through the central public Procurement portal for e procurement at <https://eprocure.gov.in/eprocure/app>
5. Tenderer who has downloaded the tender from website [www.vmmc-sjh.nic.in](http://www.vmmc-sjh.nic.in) and central public procurement portal (CPPP) website <https://eprocure.gov.in/eprocure/app>. shall not tamper / modify the tender form including downloaded price bid template in any manner. In case if the same is found to be tampered/ modified in any manner, tender will be rejected and EMD will be forfeited and tenderer would be liable to be banned from doing business with Safdarjung hospital.
6. Modification and withdrawal of bids: Bidders may modify or withdraw his online bid after submission as per the facility provided in the CPP Portal, only prior to the date and time prescribed for end of submission of bid in critical dates. No bid shall be modified after the date and time for end of submission of bids. No bid may be withdrawn in the interval between the deadline for submission of bids and expiry of the period of bid validity specified. Withdrawal of a bid during this period will result in bidders forfeiture of Earnest Deposit (EMD).
7. One bidder is permitted to submit only one bid. Failure to comply this will lead to rejection of all the bids by that bidder

8. **Attested copies of all the document uploaded as per checklist (Annexure II) and EMD if is in form of NEFT/RTGS/DD in sealed envelope should be dropped before bid opening date in Tender box, kept in Ground Floor, M.S. office opposite lift.**
9. In the event of any of the mentioned dates as per critical dates being declared as holiday, the tender will be opened on the next working day at the appointed time.
10. The Medical Superintendent reserves the right to reject any or all tenders without assigning any reason whatsoever. Incomplete conditional or delayed bids will not be considered and summarily rejected.
11. The detailed advertisement and all subsequent updates, amendments, corrigendum etc. related to the tender will only appear on website of CPPP i.e. [www.eprocure.gov.in](http://www.eprocure.gov.in)
12. Price bid must be submitted in prescribed format online. Price bid is not required to be submitted in physical form.

All statutory duties and taxes( including excise and customs) VAT and other may be clearly specified . Price quoted shall be firm and excluding all taxes whatsoever may be. Any variation in prices or items during validity of the offer shall require forfeiture of the EMD.

Minimum 50% lowest Rates quoted for the items ( mentioned in price bid) will be considered for award of contract.
