- The application containing the application form must be superscribed in bold letters "**Name of the post applied for**".
- Applications which are not in the prescribed format will be rejected.
- Applications complete in all respects and along with attested copies of the testimonials must reach to the Sports Injury Centre, Safdarjung Hospital within 45 days from the date of advertisement. Age will be reckoned from the closing date of advertisement.
- The Candidate should have the requisite academic qualification from a recognized institution for the post applied for at the time of application itself.
