26 posts of Senior Resident are reserved horizontally for Persons with Benchmark Disability (Divyangjan) including backlog vacancies as per DOPT, Govt. of India Rules.

Persons with Benchmark Disability (Divyangjan) – Only Orthopaedically Handicapped (OL, OA) are eligible (Medical Certificate from the Govt. Hospital/Institution is mandatory).

Eligibility Criteria:

The Candidate should possess Post Graduate Degree/Diploma (approved by MCI) in the concerned speciality after MBBS/BDS failing which MBBS/BDS with two years' experience in a Govt. organization out of which one year in the concerned speciality.

- **ELIGIBILITY FOR ENDOCRINOLOGY** - Desired qualification is MD/DNB in Medicine or Paediatrics
- **ELIGIBILITY FOR HAEMATOLOGY** - The candidate should possess MD or equivalent in Medicine or Paediatrics. Candidate with M.D. or equivalent in Pathology will not be eligible.

Pay Scale : Rs.67,700/- in Pay Level-11 in the Pay Matrix as per 7th CPC (Pre-revised PB-3, Rs.15600-39100 + 6600 GP) + Other allowances as admissible as per Govt. of India Rules.

Age : 45 years (For General/EWS candidates)
: 50 years (For SC/ST candidates)
: 48 years (For OBC candidates)
: For PwBD candidates - Upper age-limit is relaxable as per Govt. of India rules.

Mode of Selection: Through Interview.


Conditions of Recruitment:

1. Applicants should submit their application in the prescribed format as per Annexure-I along with the attested copies of all the relevant documents in support of their candidature for the post. One passport size photograph should also be appended. The application addressed to the Medical Superintendent, VMM College & Safdarjung Hospital, New Delhi-110029 should be **submitted in DIARY & DISPATCH SECTION of this institution (near Gate no. 2 and adjacent to Bank of Baroda, Safdarjung Hospital Branch)**. The application sent by post must have written on the top of the envelope **"Application for the post of Senior Resident on Adhoc basis in the Department of _____."** **LAST DATE OF SUBMISSION OF APPLICATION IS 10th June 2022 till 3 PM.**
2. Undertaking in application form must be signed by the candidate.
3. The institution will not be responsible for any postal delay.
4. Crucial date for determination of eligibility with reference to age, educational qualification and experience etc. will be the last date of submission of application form in this institution.
5. Candidate must be registered with the Delhi Medical Council. DMC registration certificate for both MBBS and PG is mandatory with application. Application of the candidates without DMC registration certificate (for both MBBS and PG) will be summarily rejected.
6. The appointment will be initially for a period of 89 days, which could be extended for a further period of 89 days, subject to the satisfactory work & conduct report from the concerned HOD. The maximum tenure of Senior Resident will be three years including any service rendered earlier as Senior Resident on adhoc/regular basis in any Govt. of India/State Government hospital/institution.
7. Other service conditions will be applicable as per service conditions prescribed from time to time by the Govt. of India.
8. The candidate who is already employed should submit No Objection Certificate from present employer. Reliving is required from the present employer before joining. No extension will be granted for relieving.
9. Inter - hospital/Institution transfer shall not be permitted.
10. The candidate must bring following original certificates at the time of interview-
 - a. Certificate in support of age (10th certificate)
 - b. Registration with DMC for both MBBS and PG.
 - c. Mark sheets of MBBS / BDS / MD /MS / DNB /MDS (all years).
 - d. Internship Completion Certificate.
 - e. MD/MS/DNB/Diploma Pass & Experience Certificate.
 - f. SC/ ST/OBC certificate in the prescribed format by Govt. of India.
 - g. EWS candidates to submit copy of Income & Asset Certificate as per given Annexure-III having date of issue on or after 01.04.2022 (valid for year 2022-23) vide OM No. 36039/1/2019-Estt (Res) dated 31.01.2019 of DOPT, Ministry of Personal & Public Grievance & Pensions, New Delhi.
 - h. Undergraduate and post graduate attempt certificate.
 - i. Experience certificate, if any.
 - j. No Objection Certificate, if employed in Central Govt / State Govt / PSUs / Autonomous Bodies.
11. No correspondence shall be entertained after the last date of closing of application.

****Candidate must submit the latest OBC certificate issued on or after 01-04-2022 by the competent authority of State/Govt. of India in the format prescribed by DOPT, Govt. of India for appointment to Central Government post (as per given below Annexure-II).**

12. Incomplete or/and un-signed application will be rejected and no communication will be entertained in this regard.
13. No separate call letters for interview will be issued. Candidates are advised to visit official website (www.vmmc-sjh.nic.in) of this institution at regular interval for all further notifications.
14. List of eligible candidates and selected candidates will be displayed on the official website (www.vmmc-sjh.nic.in) of this hospital.
15. **Tentative date of joining will be last week of June 2022.**
16. The candidate has to collect his/her offer of appointment from Academic Section after display of final result. The offer of appointment will stand cancelled, if acceptance to the post will not be received within the stipulated time period and the selected candidate will not join the post by **30th June 2022**.
17. A candidate has to submit **only ONE APPLICATION** mentioning clearly **only ONE DEPARTMENT** in which he/she intends to apply. **If multiple applications or one application in multiple subjects is/are received from the same candidate, all of his/her applications will be summarily rejected.**
18. Application of the candidates with DM/M.Ch/FNB/DNB(Super Specialty) qualification will be considered and selected for adhoc appointment, if candidate(s) with MD/MS/Diploma/DNB(BS) qualification is/are not available in the respective speciality/department, subject to maximum period of one year only.
