Tenderer who has downloaded the tender from the website www.vmmc-sjh.nic.in and Central Public Procurement Portal (CPPP) website <https://eprocure.gov.in/eprocure/app> , <https://eprocure.gov.in/epublish/app> shall not tamper/modify the tender form including downloaded price bid template in any manner. In case if the same is found to be tampered/modified in any manner, tender will be completely rejected and EMD would be forfeited and tenderer is liable to be banned from doing business with Safdarjung hospital.
5. Intending tenderers are advised to visit again on the website www.vmmc-sjh.nic.in and CPPP website <https://eprocure.gov.in/eprocure/app> at least 3 days prior to closing date of submission of tender for any corrigendum / addendum/ amendment.
6. Modification and Withdrawal of Bids. A bidder may modify or withdraw his online bid after submission as per the facility provided in the CPP Portal, only prior to the date and time prescribed for end of submission of Bid. No bid shall be modified after the date and time for end of submission of bids. No bid may be withdrawn in the interval between the deadline for submission of bids and expiry of the period of

bid validity specified. Withdrawal of a bid during this period will result in bidders' forfeiture of Earnest Deposit (EMD).

7. The hard copy of EMD must be dropped into the tender box kept in MS Office block, Safdarjang Hospital, New Delhi on or before bid opening date time as mentioned in critical date sheet.
